## Application and Contract Bridal Extravaganza Booth Rental Agreement

- Exhibitor has the exclusive privilege to occupy space(s) number: 1<sup>st</sup> choice: \_\_\_\_\_, 2<sup>nd</sup> choice \_\_\_\_\_, 3<sup>rd</sup> choice \_\_\_\_\_. The provided booth is 8'x10' and furnished with pipe, drape, and, *if requested*, two chairs. Booth space is only guaranteed when contract is received and booth is paid in full.
- Exhibitor agrees to exhibit *only* the following service: \_\_\_\_\_. Booth sharing without prior consent will not be permitted and could result in expulsion from the show and/or \$1085 fine per violation. Sharing the mailing list in any form may also result in expulsion from future shows and/or a \$5000 fine.
- Exhibitors participate in the show at their own risk and can not hold The Grand America or show producers liable for damages, cost, losses, or expenses resulting from any incident connected with the show. Exhibitors must also carry their own business liability insurance.
- If the event must be postponed or moved due to fire, natural disaster, or any other reason the monies paid will then be applied to the rescheduled date/location. If the event is cancelled, all deposits will be refunded.
- Exhibitor agrees to provide a gift certificate or prize for the drawings on Friday and Saturday. The prize cannot be a discount, and must be free of any obligation to the winner. Gift certificates are available at registration the first day of the show.
- Any Exhibitor who is distributing food samples within their booth should follow basic food safety guidelines and must have a garbage can within their booth.
- Exhibitor agrees to pay \$ \_\_\_\_\_ for booth rental. **Rental price does not include tables or electricity.** Half of the above rent is due now. The balance is due **30 days before the show.**
- Exhibitor agrees to pay an additional \$50 if the balance for the rented booth is not paid on time, *unless* exhibitor makes prior written arrangements with the show producer. Failure to do so may result in forfeit of all deposits paid or reassignment of booth.
- Exhibitor agrees to grant exclusive participation rights to the Bridal Extravaganza for future shows held at The Grand America for 3 years from the date of this show, or until such time as the Bridal Extravaganza grants these rights to another show producer. This agreement is for The Grand America only, and does not affect your participation at any other venues.
- Cancellations. If the Exhibitor cancels more than 60 days prior to the show, all monies paid will be returned or can be credited toward the next Bridal Extravaganza. You forfeit your deposit if cancelled 30-60 days prior to the event. If you cancel within 30 days of the event and the Bridal Extravaganza cannot resell your booth space, you will be charged the full amount of the booth.
- Mandatory Mediation/Arbitration. The parties expressly agree that any dispute, whether legal or equitable in nature, that might arise as to interpretation or enforcement of this Contract shall be submitted to mandatory mediation. If mediation is unsuccessful, the parties agree to submit the dispute to mandatory arbitration. Mediation and arbitration shall be mandatory and not permissive.
- Attorney Fees and Costs Provision. In any litigation, mediation, arbitration, or other proceeding by which one party either seeks to enforce its rights under this Contract or seeks a declaration of any rights or obligations under this Contract, the prevailing party shall be awarded its reasonable attorney fees, and costs and expenses incurred.
- Consent to Jurisdiction and Forum Selection. The parties hereto agree that all actions or proceedings arising in connection with this Contract shall be tried and litigated exclusively in the State and Federal courts located in the State of Utah.
